- Web/Computer Budget recap. Google Drive \$20/yr, DropBox \$120/yr, MultCloud \$60/yr, WebEx \$144/yr., OWT \$100/yr., add tax. ~\$475 in annual commitments.
- Moving website to Wix, \$324 per year plus tax. Drag and Drop, easier for anyone to pick up if someone were to move. Brock presented the new website thus far. Timeline 1-2 months. Stephanie motioned to approve spending \$324 on Wix Website, motion passed.
- Neighborhood Yard Sale- Activities Committee to get the word out. Andrea Hooper to lead.
